### **CABC MEMBERSHIP**

For businesses below the threshold or outside of the BID area, who only want to be involved in crime reduction initiatives.

Charged at £100 + VAT per year, (pro-rata up to 30th November).

#### Benefits

- Membership of SentrySIS and the exclusion scheme.
- Access to any CABC-specific training such as Child Sexual Exploitation Awareness.





## **BELOW THRESHOLD FOR CARDIFF MEMBERSHIP**

For businesses in the BID area with a rateable value below  $\pounds 25,000$  who want to be involved in FOR Cardiff projects.

Charged at £250 + VAT per year (pro-rata up to 30th November).

#### Benefits

- CABC membership benefits includes membership of SentrySIS and the exclusion scheme.
- Full involvement in FOR Cardiff projects including The Card, graffiti removal, training, marketing opportunities and other projects which have a discrete cost involved. (Please be aware that at times priority may be given to mandatory levy payers where relevant).

## ASSOCIATE FOR CARDIFF MEMBERSHIP

For businesses that via an anomaly are not charged a levy despite being in the FOR Cardiff area. Generally, this is where one organization occupies many small hereditaments on behalf of multiple occupiers, for example Cardiff Market, Clockwise offices, or a business such as Loosemores Solicitors which occupies multiple hereditaments.

Charged at 1% of the rateable value of the hereditaments, or at an approximate equivalent figure. Please contact the FOR Cardiff team to discuss an exact cost.

#### Benefits

- CABC membership benefits
- Full involvement in FOR Cardiff projects including The Card, graffiti removal, training, marketing opportunities, other projects which have a discrete cost involved. (Priority may be given to mandatory levy payers where relevant, and benefits with a discrete cost are ringfenced to the organization directly paying the levy and not sub-tennants).

#### OUTSIDE OF THE AREA FOR CARDIFF MEMBERSHIP

Strategic partnerships are offered to organisations outside of the FOR Cardiff area at the discretion of the board and strategic leadership team. Price on application.

#### Benefits

- Involvement in key strategic projects such as the Equality City as agreed in advance.
- Potential access to The Card for staff if agreed in advance.
- No access to general city-centre based projects such as cleansing team, or training places beyond any relevant to strategic projects.
- Will include CABC membership benefits if relevant.

## **TERMS AND CONDITIONS OF MEMBERSHIP**

Below the threshold, membership is only available to businesses operating from premises liable for non-domestic rates within the <u>FOR Cardiff area</u> with a total rateable value below £25,000. Businesses within the FOR Cardiff area who are not charged the standard FOR Cardiff levy for other reasons, including a single trading location being subdivided into multiple property assessments, should apply for Associate Membership which is charged in relation to the total rateable value of properties occupied.

- To access CABC benefits members will also need to agree to the partnership's information-sharing protocols and additional terms and conditions. These documents will be provided to you where relevant by a member of the FOR Cardiff team
- FOR Cardiff membership is linked to a specific address. Membership extends to the activities of the business at the address listed above regardless of whether the business trades from additional sites.
- The membership year runs from December 1st November 30th inclusive
- New memberships created in the final quarter of the membership year (from September 1st onward) will be charged for the remainder of the current membership year and the next full membership year in advance
- New memberships created elsewhere part way through the membership year will be charged on a pro-rata basis for the remainder of the membership year
- Membership benefits cannot be enacted until the full cost of membership for the year has been received by FOR Cardiff
- Ongoing membership cannot be cancelled by the member during the membership year
- Members can give notice at any point during the membership year that they wish to terminate their membership at the end of the membership year
- Membership will renew automatically at the start of the new membership year. Members may choose to cancel their membership during the first quarter of the membership year so long as they have not yet paid their membership fee for the year or utilized any discrete member benefits ie booked onto training courses
- FOR Cardiff membership provides the opportunity to be involved in FOR Cardiff projects rather than the right. Some projects may have limited capacity and FOR Cardiff reserves the right to exercise discretion in participation. FOR Cardiff reserves the right to refuse or terminate voluntary memberships at any time at their discretion.
- If FOR Cardiff terminates a voluntary membership part way through the membership year a pro-rata refund will be issued to the former member to cover the remainder of the membership year
- FOR Cardiff reserves the right to update these terms and conditions from time to time
